#### Can I participate in meetings?

Shadow Authority meetings are normally held in public. At present, members of the public may watch the proceedings via YouTube (see link above) in place of attending meetings in person. Members of the public who live or work in the area of the Shadow Authority may request to make a statement on any item on the public part of the agenda. Any person who wishes to make such a statement must submit their statement to the Monitoring Officer, via Democratic Services, at least 24 hours before the start of the meeting.

#### **Declarations of Interest**

Shadow Councillors are reminded that the Code of Conduct contains provisions relating to the declaration of interests. Please refer to the Code of Conduct for a fuller description of what constitutes an interest. Shadow Councillors are reminded of the seriousness of failing to declare an interest. Shadow Councillors are reminded that if they have a Discloseable Pecuniary Interest or a significant Non-Statutory Discloseable Interest in a matter to be discussed, whether registered or not, they must not take part in the debate or vote on that matter and should remove themselves from the meeting room irrespective of whether they are a member of the committee.

Members are reminded that under the Code of Conduct, they need only declare the existence of an interest if that interest is not already listed in their register of interests. When declaring an interest at a meeting, councillors are asked to state:

- The item number in which they have an interest;
- The nature of the interest; and
- Whether the interest is a Discloseable Pecuniary Interest or Non-statutory Disclosable Interest.

It is the responsibility of individual Shadow Councillors to decide whether any of these provisions apply in particular circumstances, but Shadow Councillors may wish to seek the advice of the Interim Monitoring Officer before the meeting.

#### 1. OPENING OF THE MEETING

Theresa Grant, Proper Officer, called the meeting to order and invited the High Sheriff of Northamptonshire, Mr Paul Parsons Esq., to address the meeting.

Mr Parsons stated that the first meeting of the Shadow Authority represented an historic occasion. He summarised the historic ties between the office of High Sheriff and the county of Northamptonshire, noting their origins in the middle ages. He noted that the reorganisation of local government in the county had only taken place on such a scale on one other occasion since the late 19<sup>th</sup> century.

#### 2. ELECTION OF THE CHAIR OF THE SHADOW AUTHORITY

The Democratic Services Manager called for nominations for the position of Chair of the Shadow Authority for the period 2020-21.

Councillor Alan Hills proposed and Councillor Mary Markham seconded "That Councillor Chris Millar be elected Chair of the West Northamptonshire Shadow Authority for the year 2020-21". Councillor Hills explained that he had known Councillor Millar from the time he was first elected in 2002. He praised his leadership of Daventry District Council through both good and difficult times. Councillor Markham stated that she had worked alongside Councillor Millar and felt he would make an excellent Chair.

Upon the vote being taken, the motion was carried and Councillor Chris Millar was elected Chair. He accepted office by making the Declaration of Acceptance to Office and then took the Chair.

Councillor Millar thanked members for electing him as Chair of the Shadow Authority. He explained that he intended to manage meetings in a way that would be fair and mindful of the rights of members, but also efficient and effective. He explained the procedures by which meetings would be managed and thanked members for their cooperation.

#### 3. APOLOGIES

Apologies were received from Councillor Arthur McCutcheon (NBC/NCC), Councillor Peter Matten (DDC), Councillor Abigail Medina (SNC), Councillor Ian Morris (NCC), Councillor Brian Oldham (NBC) and Councillor Lisa Samiotis (SNC)

#### 4. DECLARATIONS OF INTEREST

There were none.

## 5. CONSTITUTION AND CODE OF CONDUCT FOR THE WEST NORTHAMPTONSHIRE SHADOW AUTHORITY

Councillor Rawlinson proposed the report of the Governance Task and Finish Group of the West Northamptonshire Joint Committee for adoption. In doing so, he explained that the Task and Finish Group had sought to make the Shadow Authority as open and transparent as possible, without compromising its efficiency.

Councillor Larratt seconded adoption of the report.

Shadow Councillors commented as follows:

- The Task and Finish Group members had worked well together and had formed recommendations by consensus;
- The Shadow Authority should recognise the importance of engagement with young people and revisit the issue of a youth council;
- The Shadow Authority should find a way to advance the cause of localism in a relatively large authority area. The views of parish and town councils and voluntary organisations would be important;
- It was suggested that the importance of climate change should be reflected in the principles of decisions making set out at Article 12;
- The Chair should hold the explicit power to reorder the business of meetings so as not to inconvenience members of the public exercising their right to attend;
- The gender neutrality of the constitution was praised; and
- Some members felt that opposition councillors should have greater representation on task and finish groups.

In responding to comments, Councillor Rawlinson wished the new Task and Finish Group well in their endeavours.

**RESOLVED:** that the Shadow Authority:

- a) noted the work undertaken by the Governance Task and Finish Group of the West Northamptonshire Joint Committee (WNJC) in relation to the draft Constitution, including the Code of Conduct for Members;
- b) approved and adopted the draft Constitution for the Shadow Authority attached at Appendix 1 to the report.
- c) approved the draft Code of Conduct for Members attached to the Constitution;
- d) approved the use of a system of recording member attendance at meetings of the Shadow Authority, its Executive, Committees and Sub-committees;
- e) delegated to the Interim/Appointed Monitoring Officer of the Shadow Authority the power to make typographical and non-substantial changes to the approved constitution, in consultation with the Chair of the Governance Task and Finish Group / Shadow Executive member responsible for governance; and
- f) Agreed that the Interim/Appointed Monitoring Officer, in consultation with the Chair of Standards Committee and the Chair of the Governance Task and Finish Group commences recruitment for Statutory Independent Persons to perform the functions required in relation to standards under Article 10 of the Constitution and in relation to statutory officers' disciplinary procedures under the Staff Employment Procedure Rules.

#### 6. APPOINTMENT OF VICE-CHAIR

The Chair called for nominations for the position of Vice-Chair of the Shadow Authority for the period 2020-21.

Councillor André Gonzalez de Savage proposed and Councillor John Shephard seconded "That Councillor Pinder Chauhan be appointed Vice-Chair of the West Northamptonshire Shadow Authority for the year 2020-21". Councillor Gonzalez de Savage praised Councillor Chauhan's ability to work with businesses and the community in the local area.

Upon the vote being taken, the motion was carried and Councillor Chauhan was appointed Vice-Chair. She accepted office by making the Declaration of Acceptance of Office.

Councillor Chauhan thanked shadow councillors for electing her. She stated that she would act as the link between shadow councillors and the Chair and would represent all councillors in this regard.

#### 7. APPOINTMENT OF INTERIM STATUTORY OFFICERS

Councillor Ian McCord proposed and Councillor Jonathan Nunn seconded the adoption of the recommendations set out in the report. Councillor Alan Chantler advised the Shadow Council that, as Chair of the relevant Task and Finish Group, he was pleased that the process and resulted in a satisfactory outcome.

RESOLVED that: the Shadow Authority agreed the following officer recommendations for statutory designations as below:

- a) Mr George Candler as the Interim Head of Paid Service;
- b) Ms Susan Zeiss as the Interim Monitoring Officer; and
- c) Mr Martin Henry as the Interim Chief Finance Officer (S.151 Officer).

## 8. COMMITTEE PROPORTIONALITY AND APPOINTMENT OF MEMBERS TO COMMITTEES

The Chair invited the Monitoring Officer to present the report. The Monitoring Officer advised shadow councillors that the report asked the Shadow Authority to note or confirm a number of decisions relating to the structure and governance of the Shadow Authority. She asked members to note that the Structural Change Order mandated that the Shadow Authority adopt a Leader and Cabinet Executive as defined by Part 1A of the Local Government 2000, as well as setting out the names of the Leader and Deputy Leader of the Shadow Authority.

Shadow Councillors were advised that it remained for the Shadow Authority to confirm the apportionment of seats on committees in accordance with the requirements of the Local Government and Housing Act 1989 relating to political balance, as well as the appointment of Chairs and Deputy Chairs. A list of the members of committees, along with the Chairs and Deputy Chairs had been circulated to members prior to the meeting.

Shadow Councillors were reminded that there would have to be a separate vote in respect of recommendation v). This was because the proposal was for all groups to be represented on the Standards Committee and this would not be the case if the appointments to that committee were made in accordance with the ordinary requirements relating to political balance. Members were asked to note that, for this recommendation should take effect, the vote would require no members to vote against that particular recommendation.

Councillor Ian McCord proposed and Councillor Jonathan Nunn seconded the adoption of the recommendations set out in the report. In proposing the report, Councillor McCord made the following comments:

- The establishment of a West Northamptonshire Council would represent both a fresh start and a bright future for local government in the county;
- His visions for 2025 was for an authority that could offer outstanding provision for children's services, a care system that was integrated with the NHS and wider health economy, rising educational attainment and revitalised town centres;
- He drew attention to economic growth plans, ambitious housing and employment targets and local road and bypass schemes;
- He also underlined the protection of the countryside and natural environment
- The budget would also be balanced and reserves at healthy levels to give financial space for new investment opportunities;
- He called on shadow councillors to play their part in establishing effective and trusting partnerships with public services, parish and town councils and the voluntary and community sector, as well as businesses of all sizes; and
- He encouraged shadow councillors to work in a spirit of cooperation to resolve the issues faced by local government in the west of the county and deliver a bright future for citizens.

#### Shadow Councillors commented as follows:

- It was hoped that, in the spirit of collegiate working, all members would take the opportunity to attend and participate in committee meetings; and
- Some members felt that there should be a greater opportunity for opposition groups to participate in the work of the Task and Finish Groups;

In response, Councillor McCord stated that opposition groups had been free to choose their nominees to the Task and Finish Groups. He encouraged Shadow Councillors to speak positively of the Shadow Authority and contribute positively to achieving the common good.

#### **RESOLVED** that the Shadow Authority:

- a) Noted the creation of a leader and cabinet executive within the meaning of Part 1A of the Local Government Act 2000(a) (arrangements with respect to local authority governance) ("the shadow executive");
- b) Noted the members of the Shadow Executive Committee set out at paragraph 3.3 of the report;
- c) Received the names of the Leaders and Deputy Leaders of the political groups as set out at paragraphs 3.4 and 3.5 of the report;
- d) Agreed to constitute and decide on the allocation of places on committees between the political groups in accordance with the political balance

requirements of the Local Government and Housing Act 1989, as set out at paragraph 3.10; and

e) Confirmed the appointment of Committee Chairs, Deputy Chairs and members.

As two members voted against the recommendation to allocate a seat on the Standards Committee to the Independent Group, that part of the recommendation was not adopted.

## 9. APPOINTMENT OF INDEPENDENT REMUNERATION PANEL – MEMBERS' ALLOWANCES SCHEME

Councillor Suresh Patel proposed and Councillor Mike Warren seconded the adoption of the recommendations set out in the report. In proposing the report, Councillor Patel thanked the members of the Working Group for their input.

Shadow Councillors commented as follows:

- Some felt disappointment that the Panel would be composed of one woman and three men. Some also and also questioned the lack of a trade union representative and representatives of ethnic minorities;
- Shadow Councillors were encouraged to understand that the consideration and adopted of a scheme of allowances was a requirement of the Structural Change Order, but it was entirely possible that allowances could be set at zero; and
- The Panel would not only review allowances for the Shadow Authority, but also for the authority that would follow.

#### 1. Purpose

1.1 The purpose of this report is to recommend to the Shadow Authority the appointment of the new permanent Chief Executive for the West Northamptonshire Council.

#### 2. Recommendations

- 2.1 That Anna Earnshaw be confirmed as Chief Executive designate for the West Northamptonshire Shadow Authority from 1 October 2020 and that she be confirmed as the new permanent Chief Executive, Head of Paid Service and Returning Officer for the West Northamptonshire Council from 1 April 2021.
- 2.2 A salary of £170,000 (within the advertised salary grade £170,000 £180,000) to be effective from 1 October 2020.

#### 3. Recruitment & Selection

#### 3.1 Report Background

- 3.1.1 The Northamptonshire (Structural Changes) Order 2020 requires the Shadow Authority for West Northamptonshire to appoint a permanent Chief Executive by 31 December 2020; prior to the formation of the new authority on 1 April 2021.
- 3.1.2 A national recruitment campaign was launched in late May 2020 for the permanent Chief Executive role, together with a number of other statutory roles; including Director of Finance (Section 151), Director of Adult Social Services (DASS), Director of Legal and Democratic Services (Monitoring Officer) and a shared Director Children's Services (DCS) to sit across both unitary authorities.

- 3.1.3 In July 2020, the Senior Appointments Task and Finish Group and Senior Appointments Committee developed the Chief Executive role profile and person specification for this recruitment. They also shaped a robust, holistic selection and interview process and agreed the Members who would undertake the appointment panel.
- 3.1.4 Penna are engaged as our Executive Search Partner and have supported the interview panel in the search for candidates; in addition to the longlisting and shortlisting process; which involved a professional technical adviser/assessor.
- 3.1.5 The Panel received a total of 25 applications from this campaign at the end of June and the longlisted 10 candidates on 13 July.

A shortlist of 5 candidates was then agreed by the panel, following the technical assessment stage. Assessment and interviews took place over a two-day period; with day one (3 August) involving the main member appointment panel and also member, partner and employee stakeholder panels. 3 candidates were then selected by the main appointment panel to take part in the final interview by the main appointment panel on 4 August.

- 3.1.6 The appointment panel received a briefing and training on recruitment and selection prior to the interviews, as agreed by the Joint Committee in January.
- 3.1.7 The final Interview for the Chief Executive was undertaken on Tuesday 4 August 2020. The main appointment panel (senior appointment sub committee) comprised:

Councillor Ian McCord – Chair of the Senior Appointments Panel, Leader of the West Northamptonshire Shadow Authority and Leader of South Northants Council

Councillor Jonathan Nunn - Deputy Leader of the West Northamptonshire Shadow Authority and Leader of Northampton Borough Council.

Councillor Danielle Stone - West Northamptonshire Shadow Authority Opposition Leader (Labour) and Leader of the Labour Group at Northampton Borough Council.

Councillor Richard Auger - Leader of Daventry District Council.

Councillor Matt Golby - Leader of Northamptonshire County Council.

Councillor Chris Lofts of the Liberal Democrat Group and Leader of the Liberal Democrat Group at South Northamptonshire Council.

- 3.1.8 The conclusion of the appointment panel is to recommend the appointment of Anna Earnshaw as West Northamptonshire's new Chief Executive and designated Head of Paid Service. Anna is currently the Director of Adult Services and Deputy Chief Executive with Northamptonshire County Council and has a successful career in leadership, business change, transformation and social care; both in the public and private sector.
- 3.1.9 If agreed by the Shadow Authority, it is proposed that this appointment commences on the 1 October 2020. The role was advertised at a salary between £170 £180k, based on benchmarking of similar sized councils. The salary offer will be made at the bottom of the salary range.

#### 3.2 Issues and Choices

- 3.2.1 The assessment process on 3 August was part of a preferred approach by the Senior Appointment Task and Finish group to engage wider stakeholders to ensure a more holistic and informed recruitment process.
- 3.2.2 The panels assessed each candidate in a structured interview process against the requirements detailed in the person specification. Member, Partner and Employee stakeholder panels also fed into the process.
- 3.2.3 In recognition of the current Covid crisis all the interviews and stakeholder engagement sessions were conducted virtually and successfully using Zoom.
- 3.2.4 In accordance with the provisions of the Shadow Authority's Constitution, this recommendation has been sent in confidence to the members of the Shadow Executive in order to establish if any member of the Shadow Executive has any objection to the proposed appointment. No objections have been raised to this recommendation.

#### 4. Implications (including financial implications)

#### 4.1 Policy

4.1.1 The appointment of a Statutory Head of Paid Service by 31 December 2020 is a requirement that is laid down in the Northamptonshire (Structural Changes) Order 2020.

#### 4.2 Resources and Risk

4.2.1 The appointment of Statutory Officers will enable a safe and legal transition from the shadow authority to the Unitary Council in 2021.

#### 4.3 Legal

4.3.1 The appointments to the statutory officer designations ensures compliance with the Structural Change Order.

#### 4.4 Equality and Health

4.4.1 The appointment process followed a fair and transparent process. Eligible candidates were invited to apply to a national and open recruitment campaign.

#### 1. Purpose

1.1 The purpose of this report is to seek the Shadow Authority's approval of the Members' Allowances Scheme for 2020/21, as attached at Appendix B, to the period ending 31 March 2021, in order to comply with the requirements of the Northamptonshire (Structural Changes) Order (the Structural Changes Order), and having regard to the recommendations made by the Independent Remuneration Panel (the Panel).

#### 2. Recommendations

- 2.1 It is recommended that: -
- 2.1.1 The Shadow Authority has regard to the recommendations made by the Independent Remuneration Panel and the Members' Allowances Scheme at Appendix B be adopted.
- 2.1.2 The Shadow Authority delegate authority to the Interim Monitoring Officer to:
  - make the necessary changes to the Members' Allowances Scheme in the Shadow Authority's Constitution to reflect the Shadow Authority's decision, to include the full schedule of rates and allowances and terms and conditions; and
  - b) make arrangements for the publicity that the Shadow Authority is required to undertake in accordance with Regulation 16 of the Local Authorities (Members' Allowances) (England) Regulations 2003.

#### 3.1 Report Background

- 3.1.1 Part 4 of the Structural Changes Order requires the Shadow Authority to prepare and adopt a scheme for the payment of allowances to its Members. In order to achieve this the Structural Changes applies the Local Authorities (Members' Allowances) (England) Regulations 2003 to the Shadow Authority and its Members in the same way that the Regulations apply to the District Councils and County Council and their Members.
- 3.1.2 In order to comply with the 2003 Regulations, the Shadow Authority must adopt a Scheme having regard to the recommendations of an Independent Remuneration Panel. A Panel was formally appointed by the Shadow Authority at its meeting on 2 June 2020 with the following remit:
  - i. meet as appropriate, with support of the Interim Monitoring Officer;
  - ii. consider the provisions which apply to Members' allowances for the Shadow Authority, the roles of Members of the Shadow Authority, including special responsibilities and make appropriate recommendations to the Shadow Authority;
  - iii. consider the provisions which apply to Members' allowances for the West Northamptonshire Authority, the roles of Members of the West Northamptonshire Authority, including special responsibilities and make appropriate recommendations to the Shadow Authority:
  - iv. report to the Shadow Authority in relation to the matters at ii. and iii
- 3.1.3 The Panel met on Monday 29 June 2020 and made the following recommendations:

#### **Basic Allowance and Special Responsibility Allowances (SRA)**

- 3.1.4 The Panel recommends that no basic allowance or special responsibility allowances shall be payable to Shadow Authority Members are set out in the report attached at 'Appendix A' and reflected in the draft Members' allowances scheme attached as 'Appendix B' subject to:
  - i) The SRA for the Chair of the West Northamptonshire Shadow Authority be set at £5,000 and;
  - ii) The SRA for the Chair of the Shadow Overview and Scrutiny Committee be set at £6,459 for the Shadow period.

#### Travel, Subsistence and Dependant Carers' Allowance

3.1.5 The Panel recommends that Members should be entitled to claim travel, subsistence and dependant carers allowances for attending Shadow Authority meetings and that these should be claimed from their own Councils. The Scheme applies for the Shadow Period, being the date of commencement of the Shadow Authority until 31 March 2021.

#### 3.2 Issues and Choices

- 3.2.1 The Shadow Authority has discretion as to whether or not it accepts any of the recommendations proposed in the Panel's Report.
- 3.2.2 Whilst the Shadow Authority has discretion to resolve to make alterations to the Members' Allowances Scheme which may be different to those recommended by the Panel, it has a duty to have regard to the recommendations of the Panel in doing so. Members should give thorough consideration to the recommendations of the Panel to achieve compliance with this duty.

#### 4. Implications (including financial implications)

#### 4.1 Policy

- 4.1.1 When the Members' Allowances Scheme has been agreed, this will be published on the Shadow Authority's website. In addition to this, the Shadow Authority is also required by the Local Authorities (Members' Allowances) (England) Regulations 2003 to place an advert in one newspaper in circulation within the Shadow Authority area, showing the allowances that may be made to Members.
- 4.1.2 Members' allowances for West Northamptonshire Authority from 1 April 2021 will be reviewed by the Panel and reported to the Shadow Authority before the end of the Shadow period.

#### 4.2 Resources and Risk

- 4.2.1 Budget: The budget implications should the Shadow Authority decide to introduce the special responsibility allowances (SRAs) to the Chair of the West Northamptonshire Shadow Authority and the Chair of the Shadow Overview and Scrutiny Committee during the Shadow period, as recommended by the Independent Remuneration Panel, will be £11,459 during that period.
- 4.2.2 Claims arising from travel, subsistence and dependent carers allowance will be met by Members' respective Sovereign Councils.

#### 4.3 Legal

- 4.3.1 The Shadow Authority must establish an Independent Remuneration Panel whose function is to make recommendations to the Shadow Authority concerning allowances payable to Members. The Shadow Authority must have regard to the Panel's recommendations prior to making a Members' Allowances Scheme.
- 4.3.2 Regulation 16 of the 2003 Regulations states that after receiving a report from the Independent Remuneration Panel which sets out the Panel's recommendations, Local Authorities must ensure that copies of the report are available for inspection at their principal office at all reasonable hours. Local Authorities must also, as soon as reasonably practicable after they receive the report, publish a notice which:
  - a) states that the Authority has received recommendations from an Independent Panel in respect of its scheme of allowances;
  - b) describes the main features of the Panel's recommendations including the amounts of allowances that the Panel has recommended should be payable to Members;
  - c) states that copies of the Panel's report are available at the authority's principal office and specifies the address of the principal office.

#### 4 Equality and Health

#### Report of the Independent Remuneration Panel to the

#### **West Northamptonshire Shadow Authority**

#### 1. Introduction

- 1.1. The Northamptonshire (Structural Changes) Order 2020 (the Structural Changes Order) as amended contains specific provisions regarding Members allowances for the Shadow Council and the new West Northamptonshire Council after 2021. The Structural Changes Order applies regulations relating to Members' Allowances to the Shadow Council with modifications. The Structural Changes Order as amended requires the Shadow Council to:
  - a) Formulate proposals for the Scheme of Members' Allowances to be adopted by the Shadow Council; and
  - b) Prepare and adopt a Scheme for the payment of such allowances; and
  - c) Formulate proposals for the Scheme of Members' Allowances to be adopted by the West Northamptonshire Council
- 1.2. The Structural Changes Order applied the Local Authorities (Members' Allowances) (England) Regulations 2003 to the West Northamptonshire Shadow Council and its Members, in the same way that the regulations apply to County and District Councils and its Members. The Local Authorities (Members' Allowances) (England) Regulations 2003 put in practice a consolidated and simplified framework for allowances that covers Principal Councils and Parish and Town Councils. It is highlighted however that the Order does not, however extend these Regulations to cover a review of Parish Council allowances.
- 1.3. Part 4 of the Regulations makes provision for the establishment of an Independent Remuneration Panel to make recommendations concerning Allowances. It is for the West Northamptonshire Shadow Authority to determine its Allowances Scheme, but the Shadow Council does have a legal duty to take account of the recommendations of the Independent Remuneration Panel (the Panel).

#### 2 Background

- 2.1 The Panel was formally set up by the West Northamptonshire Shadow Authority at its inaugural meeting on 2 June 2020 with the following remit:
  - i. meet as appropriate, with support of the interim Monitoring Officer;
  - ii. consider the provisions which apply to members' allowances for the Shadow Authority, the roles of members of the Shadow Authority, including special responsibilities and make appropriate recommendations to the Shadow Authority;
  - iii. consider the provisions which apply to members' allowances for the West Northamptonshire Council, the roles of members of the West Northamptonshire Council, including special responsibilities and make appropriate recommendations to the Shadow Authority;
  - iv. report to the Shadow Authority in relation to the matters at ii. and iii.
- 2.2 The Panel comprises John Cade (Chair), Professor Ann Tate, Alan Haynes and Colin Robinson. Previously the Director of Scrutiny with Birmingham City Council, John is now a member of the Institute of Local Government Studies at the University of Birmingham and also chairs several other Independent Remuneration Panels, including that of Northampton

Borough Council. Ann is the Chair of the Board at Arden University, previously the Vice-Chancellor at the University of Northampton, Ann also served as a Board member of the Higher Education Funding Committee for England. Ann is a member of South Northamptonshire Council's Independent Remuneration Panel. Alan qualified as a Chartered Engineer and had various roles in the railway industry, including roles associated with Health and Safety. Alan retired in 2006 and since 2013 has been appointed to one of the two Independent Persons to the Standards Committee at Northampton Borough Council and is the Chair of the Independent Remuneration Panel for Northamptonshire County Council. Colin is a retired Civil Service Inspector and a member of the Independent Remuneration Panel for Daventry District Council.

All members of the Panel are therefore experienced in Independent Remuneration Panel work.

- 2.3 The Panel met remotely on 29 June 2020 and was provided with background data to assist it in forming its recommendations for a Members' Allowance Scheme for the West Northamptonshire Shadow Authority:
  - Roles and Responsibilities of the West Northamptonshire Shadow Authority, Shadow Executive, Portfolio Holders, Shadow Overview and Scrutiny Committee, the Senior Appointments Committee and the Standards Committee.
  - Current Schemes of Member Allowances for each of the four Sovereign Councils: -Daventry District Council, Northampton Borough Council, South Northamptonshire County and Northamptonshire County Council.
  - Details of the Councillors appointed to roles of special responsibility to West Northamptonshire Shadow Council
  - Travel, subsistence and dependency allowance schemes of the four Sovereign Councils

#### 3 Key Findings and recommendations

The Panel considered the information provided to it as detailed at paragraph 2.3 above and makes the following recommendations to West Northamptonshire Shadow Authority:

#### 3.1 Basic Allowance

Regulation 4 Local Authorities (Members' Allowances) (England) Regulations 2003 provides as follows:

- (1) An authority shall: -
- (a)make a scheme in accordance with these Regulations which shall provide for the payment of an allowance in respect of each year to each member of an authority, and the amount of such an allowance shall be the same for each such member ("basic allowance"); and
- (b)pay basic allowance and any other allowance permitted by these Regulations only in accordance with such a scheme.

In relation to Councillors' Scheme of Allowances, the constitution of the West Northamptonshire Shadow Authority states:

- "10 Shadow Councillors' Scheme of Allowances
- 10.1 Shadow Councillors shall be entitled to receive such allowances as are laid down from time to time in the Shadow Councillors' Scheme of Allowances."

In considering the information provided to it regarding the role of the Shadow West Northamptonshire Councillor, the Panel notes the key roles as:

- (a) as a body, they will: set the Shadow Council's major plans, policies and strategies as required by law; perform those functions identified in the 2020 Order; and take decisions on such matters as must be reserved to the full Shadow Council by law or as provided for in this Constitution:
- (b) oversee the Shadow Council's strategic and corporate management;
- (c) represent their communities and the views of their electorate in the decision making process;
- d) support, as appropriate, individuals in their dealings with the Shadow Council and represent them in seeking to resolve particular concerns or grievances;
- (e) balance the different interests of people within their constituency with a view to representing their constituency as a whole;
- (f) participate, as appropriate, in the decision-making, and overview and scrutiny processes; and
- (g) maintain the highest standards of conduct and ethics and observe the Shadow Council Members' Code of Conduct.

The Panel further notes that the West Northamptonshire Shadow Authority will not be delivering services. All Members of the West Northamptonshire Shadow Authority receive a basic allowance from their respective Sovereign Councils and the Panel considers that the roles of the West Northamptonshire Shadow Councillor will be covered by the basic allowance provided by the relevant Sovereign Councils.

The Panel therefore recommends that the basic allowance paid to Members of the West Northamptonshire Shadow Authority to be set at zero.

#### 3.2 Special Responsibility Allowances (SRAs)

Information provided to the Panel details that Shadow Authorities elsewhere agreed that SRAs would be kept to a minimum. The Panel further notes, that with the exception of the Chair of the Shadow Overview and Scrutiny Committee and the Chair and Vice Chair of the West Northamptonshire Shadow Authority, all Shadow Council Members with a role of special responsibility, are in receipt of an SRA from the Sovereign Council by whom they have been nominated. The Panel addresses each of the special responsibilities as detailed below:

#### 3.2.1 Chair and Vice Chair of the West Northamptonshire Shadow Authority

The Panel recognises that chairing a meeting of the West Northamptonshire Shadow Authority could be complex and should therefore attract an allowance. It is anticipated that the Shadow Council will meet just four times during the Shadow period and the Shadow Council will receive the support of Officers. Although the terms of reference for the Chair of the West

Northamptonshire Shadow Authority includes a civic role on behalf of the Shadow Council, the Panel agrees that civic roles would continue to be undertaken by the relevant Mayors and Chairman of the Sovereign Councils. The role of Chair of the West Northamptonshire Shadow Authority should attract an SRA for the Shadow period.

The role of the Vice Chair of the West Northamptonshire Shadow Authority is to support the Chair in his civic duties and carry out civic duties as well on behalf of the Civic Office. It is not expected that such civic duties will be undertaken. The Vice Chair is also expected to deputise in the absence of the Chair in carrying out the responsibilities of the Office of Chair. The Panel agrees that the role of Vice Chair of the West Northamptonshire Shadow Authority should not attract an SRA for the Shadow period.

The Panel therefore recommends that the SRA for the Chair of the West Northamptonshire Shadow Authority be set at £5,000 per annum and to be set at zero for the Vice-Chair for the Shadow period.

#### 3.2.2 Leader and Deputy Leader of the West Northamptonshire Shadow Authority

The Panel recognises the significance of the roles of the Leader and Deputy Leader of the Shadow Council and the time commitment expected. The Panel highlights that the Leader and Deputy Leader of the Shadow Council are both in receipt of an SRA from the Council by whom they have been nominated.

The Panel recommends that the SRA paid to the Leader and Deputy Leader of the West Northamptonshire Shadow Authority for the Shadow period be set at zero.

#### 3.2.3 Members of the Shadow Executive

The Panel recognises that the Shadow Executive will have no executive responsibility for service delivery during the Shadow period and Members of the Shadow Executive will act as a collective rather than exercising individual executive responsibility. The Shadow Executive is made up of Leaders, Deputy Leaders and a Portfolio Holder of the four Sovereign Councils, all of which are in receipt of an SRA from the Council by whom they have been nominated.

The Panel recommends that the SRA paid to the Members of the Shadow Executive of the West Northamptonshire Shadow Authority for the Shadow period be set at zero.

#### 3.2.4 Chair of the Shadow Standards Committee

The Panel recognises that the Chair and Deputy Chair of the Shadow Standards Committee are both in receipt of an SRA from the Council by whom they have been nominated.

The Panel recommends that the SRA that is paid to the Chair and the Deputy Chair of the Shadow Standards Committee be set at zero.

#### 3.2.5 Chair of the Shadow Senior Appointments Committee

The Panel recognises that the Chair and Deputy Chair of the Shadow Senior Appointments Committee are both in receipt of an SRA from the Council by whom they have been nominated.

The Panel recommends that the SRA paid to the Chair of the Shadow Senior Appointments Committee be set at zero.

#### 3.2.6 Chair of the Shadow Overview and Scrutiny Committee

The Chair of the Shadow Overview and Scrutiny Committee is not in receipt of an SRA from either Sovereign Councils (Northampton Borough Council and Northamptonshire County Council) that she is a member of.

In considering the SRA for the Chair of the Shadow Overview and Scrutiny Committee, the Panel notes the SRAs paid from the Sovereign Council for this role:

Daventry District Council £6,213

Northampton Borough Council £6,462.76

Northamptonshire CC £8,853

South Northants Council £4,308

The Panel agrees that it would be appropriate to recommend an average of the SRAs for the Chairs of the Overview and Scrutiny Committee from the four Sovereign Councils for the Chair of the Shadow Overview and Scrutiny Committee. This equates to an estimated amount of £6,459.

The Panel recommends that an SRA to be paid to the Chair of the Shadow Overview and Scrutiny Committee be set at £6,459 for the Shadow period.

#### 3.3 Travel and Subsistence and dependant carer's allowance

The Panel recognises that the four Sovereign Councils acknowledge duties undertaken by Members of the West Northamptonshire Shadow Authority as an approved duty. Therefore, any travel, subsistence and dependant carer's allowance claims can be made in accordance with the Schemes in operation by each of the Sovereign Councils.

The Panel therefore recommends that any travel, subsistence and dependant carer's allowance claims is be made in accordance with the Travel, Subsistence and Dependant Carer's Schemes in operation by each of the four Sovereign Councils.

## WEST NORTHAMPTONSHIRE SHADOW AUTHORITY SCHEME OF MEMBERS' ALLOWANCES 2020/2021

#### **GUIDANCE NOTES FOR MEMBERS**

In accordance with the Local Authorities (Member's Allowances) (England) Regulations 2003 (Statutory Instrument 2003 No 1021) this scheme was agreed at the meeting of the West Northamptonshire Shadow Authority held on 18 August 2020. This Scheme will be in place during the 2020/2021 Financial Year, beginning with the day on which the Northamptonshire (Structural Changes) Order 2020 came into force and ending on 31 March 2021 (the "Shadow Period").

1. The allowances approved for the Shadow Period are as follows:

#### 1.1. Basic Allowance

Elected Members of all Councils comprising the West Northamptonshire Shadow Authority currently receive a basic allowance from their predecessor councils to recognise the time devoted to carry out their work as Councillors, including attendance at meetings, and constituency activities. These basic allowances are intended to cover incidental costs such as travel and subsistence.

The basic allowance of each Council applies equally to the business of the West Northamptonshire Shadow Authority as a function of all Councils as they transition into a new West Northamptonshire Council from 1 April 2021 with elections to the new Council taking place in May 2021. The amount of basic allowance payable to Members by the West Northamptonshire Shadow Authority will be set at nil.

The basic allowance for members of West Northamptonshire Council from 1 April 2021 onwards will be reviewed by an Independent Remuneration Panel and reported to the West Northamptonshire Shadow Authority before the cessation of the Shadow Period.

#### 1.2. Special Responsibility Allowances (SRAs)

The amount of special responsibility allowances payable to Members by the West Northamptonshire Shadow Authority will be set at nil, subject to the following exceptions:

#### **Chair of the Shadow Overview and Scrutiny Committee**

The SRA for the Chair of the Shadow Overview and Scrutiny Committee will be set at £6,459.

#### **Chair of the West Northamptonshire Shadow Authority**

The SRA for the Chair of the Shadow Overview and Scrutiny Committee will be set at £5,000.

#### 1.3. Travelling, Subsistence and Dependant Carers' Allowances

Travel, subsistence and dependant carers' claims must be made in accordance with the Schemes operated by each of the District Councils and the County Council in West Northamptonshire, and by Members submitting claims to their respective Council. The rates for travelling and subsistence allowances are set out in the schemes of Daventry District Council, Northampton Borough Council, Northamptonshire County Council and South Northants Council.

#### 1.4. Co-opted and Independent Members

There will be no co-opted members of Committees appointed to sit on Panels and for a constituted meeting by the West Northamptonshire Shadow Authority, so no allowance is required.

During the Shadow Period, there will be an Independent Person (who will be appointed) who will be consulted on any Code of Conduct or Standards matters.

#### 2. Submission of Claims

Claims for allowances must be made in accordance with the existing arrangements operated by each of the District Councils and the County Council in West Northamptonshire of which the claimant is a Member.

#### 3. Duration of Scheme

This Scheme is for the period during the 2020/2021Financial Year, beginning with the day on which the Northamptonshire (Structural Changes) Order 2020 came into force and ending on 31 March 2021 (the "Shadow Period").

#### 4. Review of Scheme

The Scheme for the new West Northamptonshire Council from 1 April 2021 onwards, will be reviewed by an Independent Remuneration Panel and reported to the West Northamptonshire Shadow Authority before the cessation of the Shadow Period.

#### 1. Purpose

1.1.1 The purpose of this report is to advise the Shadow Authority of changes to committee membership since the last meeting of the Shadow Authority, as well as some minor changes to the Shadow Authority's constitution that have been made by the Interim Monitoring Officer under the powers delegated by the Shadow Authority. The report also provides an update further to the delegation to the Interim/Appointed Monitoring Officer to make arrangements for the appointment of an Independent Person for the Shadow Authority.

#### 2. Recommendations

- 2.1 It is recommended that the Shadow Authority:
  - a) Notes and approves the changes to committee membership set out in section 3.1;
  - b) Notes and approves the updates to the Constitution that have been made by the Monitoring Officer under powers delegated by the Shadow Authority as set out in section 3.2; and
  - c) Notes and approves the appointment of Mr Tom Edwards as Independent Person to the Shadow Authority, as set out in section 3.3.

#### 3. Issues and Choices

#### 3.1 Committee Membership

3.1.1 A range of custom and practise exists among sovereign authorities in relation to in-year changes to committee membership. In the case of the Shadow Authority, the Monitoring Officer has taken the view that changes to membership expressed by group leaders on behalf of groups should be reported to the next Shadow Authority meeting.

3.1.2 There are two changes to report, both of which concern the Overview and Scrutiny Committee. These changes generally relate to the establishment of task and finish groups by the Shadow Executive on 9<sup>th</sup> June and the appointment of Shadow Councillors to those groups. It is considered good practice to separate the membership of the task and finish groups from the Overview and Scrutiny Committee in order to avoid potential conflicts. The Shadow Authority is asked to note and approve the following changes in relation to membership of the Overview and Scrutiny Committee: Councillor David Smith has replaced Councillor John Shephard. Councillor Emma Roberts has replaced Councillor Les Marriott.

#### 3.2 The Constitution

- 3.2.1 The Shadow Authority approved a Constitution at its inaugural meeting on 2nd June 2020. The Constitution was developed by a working group established by the West Northamptonshire Joint Committee in compliance with statutory requirements, including the Structural Changes Order establishing the Shadow Authority.
- 3.2.2 At the aforementioned meeting, the Shadow Authority delegated to the Interim Monitoring Officer the power to make such typographical or non-substantial amendments to the Constitution as may be necessary. A number of such amendments have been identified and these are listed below:
  - a) Part 3 (Responsibility for Functions) contains an error at Paragraph 5.1 (g). Where it is stated the functions of the Shadow Council include "approving and adopting the Shadow Councillors' Scheme of Allowances and developing the Scheme of Allowances for West Northamptonshire Council, including any pension provision for Members..." the reference to Pensions must be removed. Councillors are precluded from becoming active members of the Local Government Pension Scheme by virtue of The Local Government Pension Scheme (Transitional Provisions, Savings and Amendment) Regulations 2014.
  - b) Part 4 B (Shadow Executive Procedure Rules) contains a cross-referencing error. At Paragraph 5.14 it states "Questions can be submitted by members of the public at meetings of the Shadow Executive Committee in accordance with Shadow Council Procedure Rule 35 and Appendix 6 of the Shadow Council Procedure Rules". This should read "in accordance with Shadow Council Procedure Rule 11 and Appendix 6"
  - c) Part 4A contains two typing errors.
    - At Paragraph 7, the word "Press" has one "s" omitted in both the heading and in the body of subparagraph 7.1.
    - At Paragraph 18 the words "or not" have been omitted from the third line of subparagraph 18.1, which should read "...Committee whether or not they are members of that body unless the body..."
  - d) Part 4D (Meeting Procedure Rules), Appendix4 Paragraph 4 contains some words which have been struck through and should have been

omitted from the final version. The words "lead officer of the Central Implementation Team" will be removed from that Paragraph.

#### 3.3 The Independent Person

- 3.3.1 The Northamptonshire (Structural Changes) Order 2020 applies various legislation regarding the conduct of members to the Shadow Authority. This includes the elements of the Localism Act 2011 that require local authorities to ensure arrangements for investigating and making decisions in relation to complaints under the Code of Conduct include provision for the appointment of one or more Independent Persons.
- 3.4.2 For the purpose of the Shadow Authority, a person may not be appointed as an Independent Person if:
  - a) they are a member or officer of the authority;
  - b) they are a relative (as defined in the Act) or close friend of a person who is a member or officer of the authority;
  - c) they have in the five years prior to their appointment been a member or officer of the authority.
  - A person may not be appointed as an Independent Person unless:
  - d) the vacancy has been advertised in such a manner as the authority considers is appropriate to bring it to the attention of the public; and
  - e) they have submitted an application to fill the vacancy of an Independent Person.
- 3.5.3 At the meeting of the Shadow Authority held on 2<sup>nd</sup> June 2020, authority was delegated to the Interim/Appointed Monitoring Officer to undertake the recruitment process to allow selection of an appropriate person(s) to the role of Independent Person.
- 3.3.2 Pursuant to this delegation, the Interim/Appointed Monitoring Officer arranged for the role to be advertised via the West Northamptonshire Authority communications and engagement channels, including the Shadow Authority's website. The role was also advertised to existing Independent Persons appointed by West Northamptonshire sovereign authorities. A number of expressions of interest were received, leading to a shortlisting and interview process. The outcome of that process is that Mr Tom Edwards is to be appointed as the Independent Person for the Shadow Authority.
- 3.3.3 Mr Tom Edwards has considerable experience as an Independent Person and currently undertakes the same role for both Cherwell District Council and South Northamptonshire Council. He is also a member of Football Association's Serious Case Panel (formerly the National Anti-Discrimination Chairman's Panel). He has significant experience of complaint investigation and handling. Mr Edwards' professional background is in Local Government in a neighbouring county, a position from which he retired in 2008.
- 3.3.4 In line with the requirements of the delegation to the Interim Monitoring Officer, both the Chair of the Standards Committee and the Chair of the Governance Task and Finish Group have been consulted on the appointment.

#### 4. Implications (including financial implications)

#### 4.1 Policy

4.1.1 The adoption of the Constitution and its proper maintenance are considered fundamental to the effective operation of the Shadow Authority.

#### 4.2 Resources and Risk

#### 4.3 Legal

4.3.2 The Constitution establishes a clear framework for the steps to be taken by the Shadow Authority in discharging its functions.
