### MAIN REPORT

### 1 APPLICATION

- 1.1 On 14th June 2023, the Council received an application for works to a Wellingtonia tree in the curtilage of the house where Councillor Cecile Irving-Swift lives. In accordance with the Constitution, Councillor Irving-Swift notified the Assistant Director Planning and Development prior to the submission of this application.
- 1.2 The tree in question is a Sequoia (Giant Redwood or Wellingtonia) subject to a tree preservation order (TPO DA 342). The application covers the removal of deadwood, which is good for maintenance of the tree but does not need to be applied for. The application also includes a crown raise, which will facilitate better access for

maintenance and grass cutting, and the removal of two branches which, because of the way they have grown, could endanger the long-term health of the tree if they were to break off. The proposals complied with good arboricultural practice and were approved accordingly.

- 1.3 In the Council's Constitution, the Planning Protocol requires that where a Member or their agent submits an application in a personal capacity it shall always be considered by a Planning Committee. It goes on to state that an application submitted by a Member shall be dealt with by the Planning Committee other than the committee to which the application relates.
- 1.4 Incorrectly, permission was granted under delegated powers for the proposed works to take place. The application has been determined and a decision issued which is now in force.
- 1.5 In order to complete the protocol, this matter needs to be reported to South Planning Committee for noting. A copy of the decision notice dated 8th September 2023 is appended to this report for information. It is understood that the works to the Wellingtonia tree are proposed to take place on Tuesday 10th October.
- 1.6 The Councils Planning Service has been subject to an independent review by the Planning Advisory Service and significant progress is being made in implementing their recommendations to improve planning service delivery. In addition a major restructuring of the Planning Service is underway and accompanying this various process reviews are occurring. These actions should ensure that the necessary staff, processes and protocols are in place to significantly reduce the likelihood of such errors occurring in the future.

1. Before any pruning work is carried out, the work shall be agreed on site between the appointed tree surgeon and the Local Planning Authority. The work shall thereafter be carried out in accordance with the details agreed on site and as confirmed in writing by the Local Planning Authority. The works shall not involve any reduction in height of the tree or any pollarding.

Reason: To ensure that the tree surgeon is fully aware of the extent of lopping granted consent.

2. All tree works shall be carried out in accordance with British Standard 3998: Recommendations for Tree Works and undertaken by suitably qualified and insured arboricultural contractors.

Reason: In the interests of good arboricultural practice.
