11. Declarations of Interest

There were no declarations of interest.

12. Minutes

The minutes of the meeting of the Committee held on 15 December 2022 were agreed as a correct record and signed by the Chair.

13. Chair's Announcements

There were no announcements from the Chair.

14. Delegation of additional Hackney Carriage and Private Hire Vehicle licensing decision making powers from Committee to Officers

The Committee considered a report from the Assistant Director – Regulatory Services which requested the Taxi and General Licensing Committee delegate additional decision making powers concerning Hackney Carriage and Private Hire Vehicle licensing matters from the Committee to Licensing Officers.

In introducing the report, the Licensing and Environmental Support Services Manager explained that under the present constitutional arrangements, in situations where an applicant for a Hackney Carriage or Private Hire Vehicle Licence had relevant convictions or cautions, and/or had reached the threshold of nine or more penalty points on their driver's licence, the matter would be referred to a meeting of the Taxi & General Licensing Sub-Committee for a decision on whether the applicant was deemed to be a 'fit and proper person' to hold a Hackney Carriage or Private Hire Vehicle Licence.

The Licensing and Environmental Support Services Manage explained that the knock-on operational impact of this was that at present, the Assistant Director – Regulatory Services did not have the authority at present to immediately revoke a Hackney Carriage or Private Hire Vehicle Licence on the grounds of an imminent risk to public safety, and instead they would have to refer the matter to a Taxi and General Licensing Sub-Committee to determine the matter.

In response to questions from the Committee regarding why Officers had formed the view that urgent matters should be determined by the Assistant Director – Regulatory Services and not a Taxi & General Licensing Sub-Committee, the Licensing and Environmental Support Services Manager advised that the process of organising Sub-Committees, writing reports, and holding hearings was onerous and lengthy and can occasionally lead to delays of several months in determining cases. Sub-Committees must currently determine matters involving convictions for even the most minor of offences, some of which had no real bearing on whether a person is fit and proper to hold a Hackney Carriage or Private Hire Vehicle driver or operator license. Altering the scheme of delegation as proposed would have the effect of reserving and Sub-Committee hearings only for the most serious or complicated cases and speeding up the decision making process, which would also be in the best interests of the Hackney Carriage and Private Hire Vehicle trades.

It was proposed by Councillor Gareth Eales and seconded by Councillor Sally Beardsworth that authority be delegated to the Assistant Director — Regulatory Services in consultation with the Chair of the Taxi & General Licensing Committee to make decisions concerning Hackney Carriage and Private Hire Vehicle licensing matters where there is perceived to be an imminent risk to public safety which would justify the use of the power under section 61 (2B) of the Local Government (Miscellaneous Provisions) Act 1976 to revoke a driver's license with immediate effect, in circumstances where the holder of an current Hackney Carriage or Private Hire Vehicle driver's license has relevant convictions and/or cautions and/or has nine or more points on their DVLA driving licence.

The motion was put to the vote with eleven votes cast in favour of the proposal and one cast against, therefore the motion was carried.

Resolved

(1) That authority be delegated to the Assistant Director – Regulatory Services in consultation with the Chair of the Taxi & General Licensing Committee to make decisions concerning Hackney Carriage and Private Hire Vehicle licensing matters where there is perceived to be an imminent risk to public safety which would justify the use of the power under section 61 (2B) of the Local Government (Miscellaneous Provisions) Act 1976 to revoke a driver's license with immediate effect, in circumstances where the holder of an current Hackney Carriage or Private Hire Vehicle driver's license has relevant convictions and/or cautions and/or has nine or more points on their DVLA driving licence.

15. **Draft Street Trading Policy**

The Committee considered a report from the Assistant Director – Regulatory Services which requested the Committee to commence the creation of a West Northamptonshire Council Street Trading licensing regime under the Local Government (Miscellaneous Provisions) Act 1982 ("the 1982 Act") and to approve a draft designation of streets for the purposes of Street Trading and a draft Council Street Trading policy, both of which will then be the subject of a statutory and public consultation process and a further report to Committee.

In introducing the report, the Licensing and Environmental Support Services Manager explained that the Draft Street Trading Policy sought to simplify and updates the three predecessor councils' street trading policies, which remain in force until expressly replaced by West Northamptonshire Council, due to the operation of local government reorganisation legislation, and to ensure consistency of approach with regard to Street Trading throughout the West Northamptonshire Council area.

A fair, clear, and consistent West Northamptonshire Council Street Trading licensing regime, underpinned by a single, unified policy, would therefore ensure that the Council can put in place controls to protect the public and provide a level playing field for street traders. It would also allow the Council to attach conditions to consents or licenses in relation to food hygiene and make sure that licence holders keep the licensed sites clean.

Resolved

- (1) That it Schedule 4 of the 1982 Act shall henceforth apply to the District area of West Northamptonshire Council for the purpose of regulating street trading in accordance with the Act.
- (2) That the draft Council Street Trading Policy be approved for statutory and public consultation, the results of which will be the subject of a further report to Committee with a view to formally making a Council Street Trading Policy.

Approval of the designation of streets for the purpose of Street Trading in the West Northamptonshire Council area

Report of the Assistant Director – Regulatory Services

This report is public

Purpose of report

To ask the Committee to approve the designation of streets for the purposes of Street Trading.

1.0 Recommendations

The Committee is recommended to:

(i) Pass a resolution to designate certain streets as prohibited or consent streets for the purposes of street trading in accordance with the list in Appendix A and as detailed in the statutory notice published on the 9th of March 2023 (Appendix B).

2.0 Introduction

- 2.1 On the 24th of January 2023 the Committee agreed with the recommendation in relation to the designation of streets in the West Northants Council area as prohibited or consent for the purposes of street trading.
- 2.2 Following that meeting, in accordance with the statutory requirements, a notice was published on the 9th of March 2023 which invited representations in respect of the Council's intention to pass a resolution to so designate those streets.
- 2.3 Before deciding whether to pass such a resolution the Committee must consider any representations in response to the notice of the 9th of March 2023.

3.0 Report Details

- 3.1 The Local Government (Miscellaneous Provisions) Act 1982 prescribes a statutory process to be followed in relation to the designation of prohibited, licensed and consent streets for the purpose of street trading.
- 3.2 The Act requires publication of a notice of intention to make a resolution to designate streets prior to any such resolution being made. Should such a resolution be made 2 further notices must be published before any designation comes into force.
- 3.3 The table below is an indicative timetable for the making of the resolution and publication of statutory notices.

9 March 2023	Newspaper notice advertising proposal to make a resolution.
18 April 2023	Report to Committee to consider any representations from the above notice and make the resolution.
27 April 2023	First post resolution newspaper notice a minimum of 28 days before the resolution comes into effect.
4 May 2023	Second post resolution newspaper notice no later than 7 days after the first post resolution notice.
25 May 2023	Designation comes into force, a minimum of 28 days after the first post resolution notice.

- 3.4 On the 9th of March 2023 a notice was published in the Northampton Chronicle and Echo giving notice of the Council's intention to make a resolution in relation to the designation of prohibited and consent streets for the purpose of street trading.
- 3.6 The Act prescribes a period of 28 days from the date of publication of the notice for any representations to be made in respect of the intention to make a resolution.
- 3.7 The Act also requires that the chief officer of police and the highway authority responsible for any streets to which the proposal relates are consulted with.
- 3.8 We received one representation from a business currently trading in the area (**Appendix C**). The business in question has been trading illegally on a prohibited street and would like the designation of that street changing from prohibited to consent. The location is a lay-by on the Harlestone Road close to Harlestone Firs. It is currently prohibited as the road has a 40mph speed limit and the lay-by is open with no buffer between it and the road.

4.0 Conclusion and Reasons for Recommendations

- 4.1 The Committee is recommended to:
 - (i) Pass a resolution to designate certain streets as prohibited or consent streets for the purposes of street trading in accordance with the list in Appendix A and as detailed in the statutory notice published on the 9th of March 2023 (Appendix B)

PROPOSED REGULATION OF STREET TRADING

NOTICE IS HEREBY GIVEN that West Northamptonshire Council, pursuant to its adopted powers under Section 3 and para 2 of Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982, intends to pass a resolution at the Taxi and Licensing Committee on the 18th of April to designate all streets within the West Northamptonshire Council area as either consent streets or prohibited streets for the purpose of street trading. A draft of the proposed resolution is set out below:

"RESOLVED that the Council, pursuant to Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982, designates all streets within the West Northamptonshire Council area as either consent streets or prohibited streets (list available on request) for the purpose of street trading.

The designation shall take effect on the 17th of May"


If the resolution is passed by the Taxi and General Licensing Committee. anyone who engages in street trading on any prohibited street or any consent street within the West Northamptonshire Council area without having obtained consent will commit an offence and will be liable on summary conviction to a fine not exceeding £1,000.

Anyone wishing to make representations about the intended resolution should do so in writing to the Licensing and Business Support Manager, at the email address below, no later than the 6th of April.

The Taxi and General Licensing Committee will consider all representations received by that date before deciding whether to pass the resolution.

As a family company, we have been trading at this site for over 60 years and there has NEVER been any safety issue, or concern raised.

We received a letter on 13th March from Mikolaj Waligorski, the licencing officer at Daventry Council, stating that we must cease trading at this site due to a safety concern, as this is a prohibitive road. This is the first time we have been made aware of this.

We are a well-respected, long standing local family firm and we take great pride in providing the county with the highest quality ice cream, in a safe environment. We have worked in conjunction with the council on a number of events and our customers have grown up buying our ice cream at Harlestone Firs.

This site is isolated, away from housing and next to a garden centre, in a purpose built parking bay. The traffic has recently been made calmer by the addition of a roundabout and further improvements are imminent as the new bypass will take even more traffic away from this area.

We have always taken the Health and safety of our customers into consideration and produce risk assessments for each site. (I have attached this)

I am also attaching a letter from Alan Eaton MBE, the organiser of the Hollowell Steam Rally, who we have worked with for very many years, who can vouch for our safety record.

For over 60 years, we have operated at Abington Park, now under a street vendors licence. We would be happy to discuss a similar arrangement at Harlestone Firs, if this could be arranged.
