Variation of Premises Licence Application Cyver Stores, 7 Booth Lane North, Northampton, NN3 6JE

Report of the Senior Licensing Enforcement Officer

1.0 Purpose of Report

- 1.1 To consider an application for a variation to a premises licence PL0344 for Cyver Stores at 7 Booth Lane North, Northampton submitted in accordance with section 34 of the Licensing Act 2003 (“the Act”) and made on behalf of Kandiah Rajaratnam and his wife Vasuki Rajaratnam (“Applicant” & Licence Holder) by licensing consultant Patrick Burke of PMB Licensing.

2.0 Summary

- 2.1 An application for the variation was submitted on behalf of Kandiah Rajaratnam by PMB Licensing and was received by West Northamptonshire Council on 28th February 2023. Clarification was sought by the licensing enforcement officer on the fact that the application was made on behalf of Kandiah Rajaratnam, but the licence is currently in the name of Vasuki Rajaratnam. It was confirmed that Kandiah Rajaratnam is Vasuki’s Rajaratnam’s husband and business partner, and that this application is being done in full agreement with Vasuki Rajaratnam and also on her behalf.

3.0 Application Details

- 3.1 The application was submitted with the intention to vary the premises licence by extending the current hours permitted for the sale of alcohol for consumption off the premises.
- 3.2 The current licensable indoor activities and times permitted for PL0344 are as follows:
Sale of alcohol by retail (on & off premises)
Monday – Sunday 06.00 – 00.00hrs (6am – Midnight)
- 3.3 The variation proposal is to the licence as follows:

Sale of Alcohol by retail (off the premises)

Monday – Sunday 05.00 – 03.00hrs (5am – 3am)

4.0 Consultations/Representations

- 4.1 When a request for the full variation of a premises licence or club premises certificate is received, the applicant must display a notice at or near the premises and serve a copy of the application onto the responsible authorities. For electronic applications it is a requirement of the local authority to serve a copy of the application onto the responsible authorities. This gives responsible authorities and interested parties the opportunity to make representations in relation to the application for a period of 28 calendar days. The last date for making representations was 27th March 2023.
- 4.2 The obligatory notice was displayed on the premises as verified by licensing officers on the premises and in a local newspaper.
- 4.3 The Licensing Department has received relevant representations from several members of the public all on the grounds of The Prevention of Public Nuisance. These objections can be seen at Appendix D in a single document that has been redacted of some personal information for the purposes of data protection regulations.
- 4.4 Northamptonshire Police have considered the application but have made no representation.
- 4.5 No representation has been made by any other responsible authority.

5.0 Attendance

- 5.1 The local authority is required to send a notice of hearing to all interested parties and request confirmation of attendance. A notice of hearing was sent to the following persons on 5th April 2023 :

6.0 Plan of Premises Layout & Location

There are no changes to the licensing plan applied for in this application.

7.0 Financial & Resource Implications

- 7.1. A decision made by the licensing sub-committee in respect of this application may be appealed to the Magistrates Court by the applicant or other interested party which could lead to West Northamptonshire Council being liable to legal costs.

8.0 Legal Implications

- 8.1 Having regard to the public representations received in relation to this application and taking them into account, the Sub-Committee must make a decision to take such reasonable and proportionate steps as it considers appropriate, if any, for the promotion of the four licensing objectives. The steps available are either to modify the conditions of the premises licence or reject all or part of the application.
- 8.2 The Sub-Committee must take account of the Government guidance issued in relation to the Licensing Act when making their decision. Paragraphs relevant to this particular application are;
- Para 9.43 - decisions “*should be evidence based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve.*”
 - Para 9.44 - a licensing authority “*should aim to consider the potential burden that any condition would impose of the premises licence holder (such as the financial burden due to restrictions on licensable activities)*” as well as “*However, it is imperative that the (licensing) authority ensures that the factors which form the basis of its determination are limited to consideration of the promotion of the objectives and nothing outside those parameters.*” Licensing authorities are also expected to make decisions based on assessments of both the risks and benefits either for or against making that decision.
 - Para 10.13 - Councils “*... must always consider each application and must not impose predetermined licensed opening hours, without giving individual consideration to the merits of each application*”. Paragraph 10.15 states that “*Shops, stores and supermarkets should normally be free to provide sales of alcohol for consumption off the premises at any times when the retail outlet is open unless there are good reasons, based on the licensing objectives, for restricting those hours.*”
 - Para 14.9 – Issue of “need” – “*Need ...is a matter for the planning authority and for the market. This is not a matter for a licensing authority in discharging its licensing functions ...*”
- 8.3 A decision must be made by the Sub-Committee within five working days of the hearing and a written notice containing the full reasons for that decision

must be supplied “forthwith” to the Applicant and any person that submitted a relevant representation.

- 8.4 If the Applicant or any person that submitted a relevant representation are aggrieved by the Sub-Committee’s decision, they may appeal to a Magistrates’ Court within 21 days of receipt of a copy of the written decision notice.

9.0 Options

- 9.1 If representations are received, then at the end of the consultation period the licensing authority must hold a hearing to consider them. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and,
- the protection of children from harm.

- 9.2 The steps the Sub-Committee can take are to:

- grant the application in full;
- reject the whole of the application;
- reject part of the application; or,
- to modify the conditions of the licence (excluding the mandatory conditions) by altering them, omitting them, or adding new conditions.

10.0 Policy Considerations

- 10.1 Statement of Licensing Policy

- 10.2 Guidance issued under section 182 of the Licensing Act 2003.

Section 9 gives guidance for determination of this application.

Paragraphs 8.50, 8.74 to 8.77 and Part 10 highlight the elements of the Guidance that are most relevant with respect to this application. This is not exhaustive, and the guidance should be considered fully prior to making decisions with respect to applications.

11.0 Committee


Each application must be considered on its own merits and any conditions attached to licences and certificates must be tailored to the individual style and characteristics of the premises and events concerned. This is essential to avoid the imposition of disproportionate and overly burdensome conditions on premises where there is no need for such conditions. Standardised conditions

should be avoided and indeed, may be unlawful where they cannot be shown to be necessary for the promotion of the licensing objectives in any individual case.

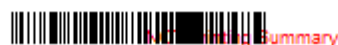

ANNEX 1 - MANDATORY CONDITIONS

19 Mandatory conditions where licence authorises supply of alcohol

(1) No supply of alcohol may be made under the premises licence -

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Conditions of Licensing Sub Committee 15th August 2006

Warning Posters must be clearly displayed posters in prominent positions throughout the shop warning that you must be 18 or over to purchase alcohol.

Conditions of Consent Order 2010

The premises to adopt a 'Challenge 25' policy in relation to the sale of alcohol.

CCTV to be recording at all times the business is open for the sale of alcohol, to cover the area of the till, the recordings to be kept for 30 days.

Litter collecting outside the store frontage to be swept up twice a day.

Appropriate staff training to be satisfactorily completed and recorded, the records to be made available for inspection by appropriate officers of the responsible authorities upon reasonable request.

A refusals book to be maintained and made available for inspection by appropriate officers of the responsible authorities upon request.

ANNEX 2 - ADDITIONAL MANDATORY CONDITIONS

The following mandatory conditions are to be applied to the licence stated above in accordance with The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 as amended by The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014.

The following conditions shall come into force on 1st October 2014

3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale of alcohol or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried out in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -

- (a) A holographic mark, or
- (b) An ultraviolet feature.

The following mandatory conditions are to be applied to the licence stated above in accordance with The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014.

The following conditions shall come into force on 28th May 2014

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1-

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
- (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

Where -

- (i) P is the permitted price,
 - (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
 - (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a

supply of alcohol under such a licence;


(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

- A Refusals Register is to be used to record all incidents when a sale is refused. The register is to be kept in the store at all times unless it is requested by authorised officers of responsible authorities. The Refusal/Challenge Register is to be checked and signed off by the Designated Premises Supervisor every two weeks.

An incident log shall be kept at the premises, and made available on request to a Responsible Authority officer. It must be completed within 24 hours of the incident and will record the following: all crimes reported to the venue; any ejections of patrons; any complaints received concerning crime and disorder; any incidents of disorder; any faults in the CCTV system, searching equipment or scanning equipment; any refusal of the sale of alcohol; and any visit by a relevant authority or emergency service.

Prior to undertaking any work at the Premises, paid or unpaid, the Premises Licence Holder shall undertake a right to work check on any prospective employee to make sure that he or she has the right to work in the UK. The Premises Licence Holder will record this check in the Premises' Right to Work register a copy of which shall be kept at the Premises and made available for inspection by a Responsible Authority officer on request. It shall record the following: The name of the employee The date of birth of the employee A copy of the

	employee's photographic ID document proving his or her right to work in the UK The date upon which the employee's status is to be reviewed and his or her right to work in the UK re-confirmed.

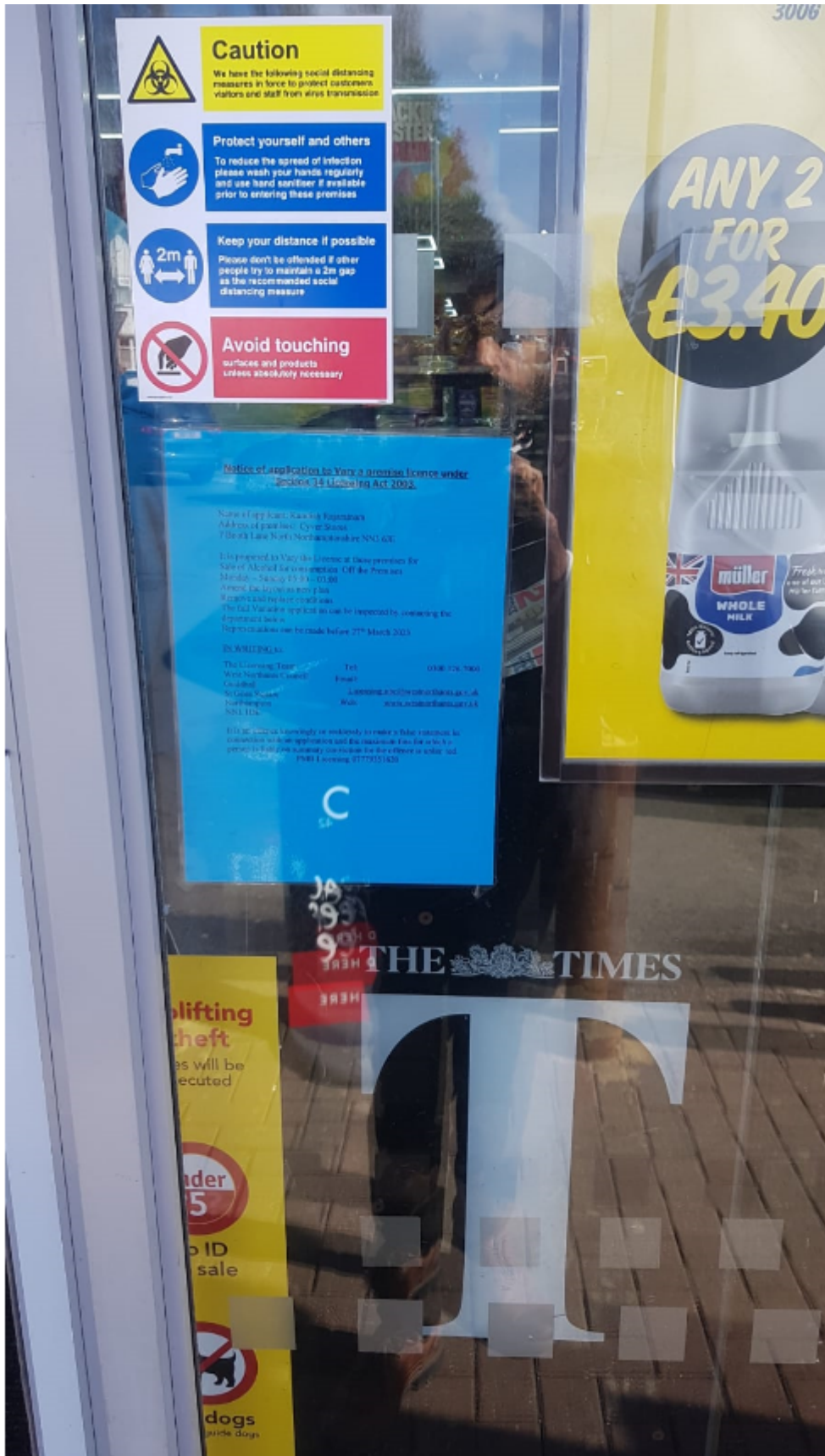

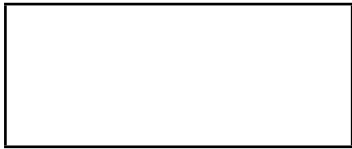

Re - Objection to the application to extend the opening hours of Cyver Stores, 7 Booth Lane North, Northampton NN3 6JE. License number - PL0344. Variation Application Number - 083637. The proposed new hours of opening being Monday to Sunday from 5am to 3am.

As explained in our previous emails, we live next door to this store at 9 Booth Lane North, and we object to the proposal to extend the stores opening hours, as we are very concerned about what this would mean for us and the local community as a whole. Given the problems that we currently encounter in relation to this store at present.

Our main concerns are: -

- An increase in anti-social behaviour, - it's not unusual for us to have people urinating down our driveway when they visit the store during the evening, and on occasion, we have witnessed drug use, with discarded syringes, and small polythene bags (*drug baggies*), which can be indicative of illegal substance use. More recently we have seen a large number of discarded nitrous oxide canisters scattered around the shop frontage, and we have witnessed drivers inhaling these canisters from balloons prior to driving away from the shop.
- Noise, slamming of car doors, and loud music from parked vehicles, which are often parked across our driveway, as this is used as over spill parking by customers!
- Insufficient parking leads to drivers parking inconsiderately, i.e on grass verges and staggering the footpath at the junction of Booth Lane North and Kettering Road North.
- Customers buy alcohol from the store and stand around drinking in groups, - they also congregate around the rear of the shop, which is adjacent to our back garden.
- Litter, - the bin outside of the shop is always full, and is not emptied frequently enough, meaning that excess litter ends up in gardens, and is strewn along the road.
- We have a constant and ongoing problem with rats in the area (not helped by the overflowing bins).
- The proposed extended store opening times are not something that the local community will benefit from, as most people using this store late into the night are not local residents.
- The store is in a built-up residential area that will no doubt become a magnet for those seeking to buy alcohol when nightclubs and other drinking venues close in the early hours of the morning.
- In November 2022, the local police called on us in relation to reports of a firearm being discharged outside of the store. We did indeed hear these shots, which was very unsettling. But this is indicative of the problems that we have in the area as a direct result of the shop opening times and the number of people loitering in the street around the neighbourhood, many of which are drawn to the area in order to buy alcohol late into the night.

It is bad enough for us and the local neighbourhood that this store managed to get a previous extension of their opening hours to midnight. This was not something we were aware of until the extension was granted. We believe that on that occasion the store owner did not display a notification of this proposal. Hence, we and our neighbours were unable to comment on this.

This store lowers the tone of the neighbourhood, and the store owner lacks any empathy or understanding in relation to any issues we have previously raised with him.

Rather than extend the opening hours of this store, please consider a reduction in the store hours, as opening until midnight and then reopening for business at 5am in the morning gives us and our neighbours very little respite from the hustle and bustle of people visiting the store during unsocial hours, and often exhibiting antisocial behaviours. The proposed new opening times will mean the shop closes for just two hours a day! We have a fourteen year old daughter who also suffers as a result of night time disturbances we encounter with great frequency.

We have lived in our house for 20 years, and it really is no exaggeration to say that this store, its customers and the shop owner have made our lives a living hell. We hope that you will do the right thing for us and the local community and reject this proposal.

Thank you for this email and the more detail that it will present to a licensing sub-committee should this matter come to a hearing. The applicant is still considering his position in discussion with his agent who I made aware yesterday of the growing number of representations we have received.

I must just manage your expectations on one point in your email however and that is to say if the applicant does decide to continue with his application the powers that a sub-committee have at this type of hearing will not include reducing any licensable activity and hours that already exist. I have looked at the history of this premises licence and the sale of alcohol permission between 06.30 and 00.00 each day has been in place since at last 2010 so there has been no increase in permitted hours in at least the last 13 years. It may be that not all the permitted hours were used by previous licence holders and I note that this licence has changed hands several time over it's licensing history and this latest licensee has decided to use the permissions to their full extent.

We already suffer from noise and disturbances late at night in Booth Lane North associated with noisy pedestrians and traffic exiting the area of the Cyver Stores shop, often discarding waste en route. Our garden and the verges fronting Booth Lane North and Rowan Avenue are the dumping ground for waste snack packaging, drink bottles, cans and especially since the expansion of the shop in recent months, numerous 'Vaping' cartridges and the packaging thereof.

Discarded syringes and prophylactics are also found in the area and particularly, stuffed into the boundary hedges of my property.

There is already a problem with excess litter frequently overflowing the bins in the area of the shop associated with rodent infestation, this having been reported on numerous occasions to the Council offices.

Noise.

In reference to the Cyver Store's application to extend their opening hours from 5am - 3am.

We would like you to be aware of further very damning evidence of how the Rajaratnam's are running their business. Please see the attached photo's which show a supermarket trolley, to the rear of the store, which is full of alcohol!!! This has been evident for several weeks now. We initially believed this to be a pallet of high-energy drinks, i.e Monster Energy.

However, on closer inspection after seeing one of the empty cans next to the bin at the front of the shop, it was found to be a trolley full of strong beer, - 8.5 percent!

This area of the store's land is accessible by the general public, including children which we often witness on this land.

Not only does this provide further evidence that this store should not be granted an extension to its opening hours, but most importantly, this surely constitutes an urgent review of how this store is operating in relation to the Rajaratnam's fitness to run such a business. The applicant is suggesting opening his shop to sell alcohol between 5.00 and 3.00. (22 hrs a day!!!)

Boothville is a residential area and as such does not want to encourage the sale of alcohol 22 hours a day! This would cause nuisance through addition traffic coming into a very small area. The noise of the vehicles, their occupants and general movement during the night would be most unwelcome.

I have lived in Boothville 31 years and think it it unnecessary to have a shop open for these hours selling booze. Had it been a pharmacy or something that meets people's urgent needs my opinion would be different but in this case i am totally against a nearly 24 hr alcohol shop.

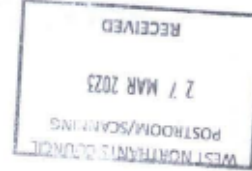

I write to **OBJECT strongly** to the proposed change in opening hours. We already suffer from noise and disturbances late at night in Booth Lane North associated with noisy pedestrians and traffic exiting the area of the Cyver Stores shop, often discarding waste en route. Our garden and the verges fronting Booth Lane North and Rowan Avenue are the dumping ground for waste snack packaging, drink bottles, cans and especially since the expansion of the shop in recent months, numerous 'Vaping' cartridges and the packaging from them. Discarded syringes and prophylactics are also found in the area and particularly, stuffed into the boundary hedges of my property.

There is already a problem with excess litter frequently overflowing the bins in the area of the shop, this having been reported on numerous occasions to the Council offices, associated rodent infestation.

If an opening time variation is to be considered then it should be a **REDUCTION** from midnight to 10pm or earlier, rather than the increase of 3 hours proposed beyond midnight into the following morning. The shop is situated in the residential **Boothville Garden Village Conservation area**, and approval of this application will serve to degrade the area. There can be no justification for this application on service to the community grounds – very, very few residents are ever likely to want to buy goods between 12 and 3 am Monday to Sunday.
