To consider a Licensing Act application for a variation to a premises licence for; TGR Bar and Restaurant Ltd, The Green Room, 6-8 Bridge Street, Brackley, NN13 7EP

1.0 Recommendations

1.1 To determine the application for a variation to premises licence in accordance with the Licensing Act 2003.

2.0 Introduction

2.1 To consider an application for a variation to a premises licence for TGR Bar and Restaurant Ltd, The Green Room, 6 – 8 Bridge Street, Brackley, NN13 7EP

3.0 Report details

- 3.1 The Green Room at Brackley is a bar and restaurant that currently benefits from a premises licence issued in accordance with the Licensing Act 2003, covering sale of alcohol for on the premises: Monday 10.00 19.00 and Tuesday Sunday 10.00 23.00, live music indoors: Friday Saturday 19.00 22.00 and recorded music indoors: Monday 08.00 19.00, Tuesday Saturday 08.00 23.00 and Sunday 09.00 23.00. A copy of the licence can be found in **appendix 1**.
- 3.2 An application for a Licensing Act 2003 premises licence variation was submitted by TGR Bar and Restaurant Ltd to West Northamptonshire Council on 17 May 2021. The application is for the following changes: sale of alcohol on the premises: Monday Thursday 10.00 00.00, Friday Saturday 10.00 01.00 and Sunday 10.00 23.00, recorded music indoors: Monday Thursday 10.00 01.00, Friday Saturday 10.00 02.00 and Sunday 10.00 23.00 and the addition of late night refreshment both indoors and outdoors: Monday Thursday 10.00 00.00, Friday Saturday 10.00 01.00 and Sunday 10.00 23.00. A copy of the application can be found at **appendix 2**.

4.0 Conclusion and reasons for recommendations

4.1 In considering the representation received and what is appropriate for the promotion of the licensing objectives, the steps the sub-committee can take are outlined in paragraph 6.2.

5.0 Consultation

- When an application for a premises licence is submitted the applicant must display a blue notice at or near the relevant premises and advertise the application in a local publication no later than 10 days after submitting the application. The consultation period runs for 28 days from the day after the application is received. This gives interested parties and responsible authorities the opportunity to make representations in relation to the application.
- 5.2 The responses from responsible authorities were as follows:
 - Child protection no response
 - Planning no response
 - Environmental protection no objection
 - Fire no comment
 - Health protection no response
 - Local health authority no response
 - Police no objection
 - Public health licensing no response
 - Secretary of state no response
 - Trading standard no response
- 5.2 We have received objections from members of the public and they are attached at **appendix 3.**
- 5.3 The applicant and the interested parties submitting representations have been invited to attend.
- 5.4 Planning supplied a late response to consultation advising of planning restrictions, this information is attached in **appendix 4**.

6.0 Alternative options

- 6.1 At the end of the consultation period the licensing authority must hold a hearing if relevant representations are received, unless the authority, the applicant and each person making a representation agree that a hearing is unnecessary. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:
 - the prevention of crime and disorder
 - public safety
 - the prevention of public nuisance
 - the protection of children from harm
- 6.2 The steps the sub-committee can take are to:

- to grant the licence subject to conditions as appropriate if it is considered necessary to promote the licensing objectives;
- Exclude a licensable activity
- Refuse to specify a person named as the DPS
- Reject the application

Annexe 1 – Mandatory Conditions

Conditions relating to the supply of Alcohol

If this premises licence authorises the sale of alcohol:-

- No supply of alcohol may be made under the premises licence at times when there is no designated premises supervisor in respect of the premises licence or at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises
 - (A) In this condition, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children:-
 - (i) games or other activities which require or encourage, or are designed to require or encourage, individuals to:-
 - (a) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (b) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (ii) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (iii) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (iv) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on:-
 - (a) the outcome of a race, competition or other event or process, or
 - (b) the likelihood of anything occurring or not occurring;
 - (v) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

- 7. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 8. The responsible person shall ensure that:-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:-
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures
- 9. A) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price
 - B) In this condition:-
 - i)"permitted price" is the price found by applying the formula P=D+(DxV) where -
 - (a) P is the permitted price
 - (b) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of alcohol, and
 - (c) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of alcohol;
 - ii) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - iii) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
 - (a) The holder of the premises licence
 - (b) The designated premises supervisor (if any) in respect of such a licence, or
 - (c) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
- iv) "relevant person" means , in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- v) "value added tax" means value added tax charged in accordance with Value Added Tax Act 1994.
- C) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny.
- D) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

If this premises licence authorises the exhibition of films:-

 Admission of children must be restricted in accordance with any recommendation made by the British Board of Film Classification, or, where there is no such recommendation or the licensing authority has notified the holder that section 20(3)(b) of the Licensing Act 2003 applies to the film, the recommendation of the licensing authority.

If this premises licence details the use of door supervisors:-

- 1. Each individual at the licensed premises to carry out security activity (an activity to which paragraph 2(1)(a) of Schedule 2 of the Private Security Industries Act 2001 applies, and which is licensable conduct for the purposes of that Act) must:
- a) Be authorised to carry out that activity by a licence granted under the Private Security Industries Act 2001; or
- b) Be entitled to carry out that activity by virtue of section 4 of that Act.

Annexe 2 - Conditions consistent with the Operating Schedule

General Conditions

The premises will adhere to an age verification policy. Signs advertising this policy will be placed in all area where alcohol is exposed for sale

Prevention of Crime and Disorder

All staff involved in the retail of alcohol will be training in relation to the law regarding its sale. This training must be completed prior to the commencement of employment. A record of this training must be kept and maintained with a copy of the syllabus attached. The recipient of the training must sign to state they have received and understood the training and this should be dated. This record must be kept on the premises at all times and made available for inspection following a reasonable request from an officer from a responsible authority

Public Safety

Standard conditions as in section A, Free tap water and designated smoking areas. First aider on site.

Prevention of Public Nuisance

Standard conditions as in section A, Alcohol Free Zones, quiet notices, staff training. No alcohol permitted outside the front of premises

Restrictions on noise emanating from the premise; no licensable activities after 22.30 outside the premises.




Protection of Children from Harm

All children on the premises ages 16 years old must be supervised by a person aged no less than 18 years old at all times when alcohol is exposed for sale.

No children under the age of 16 years old shall be permitted to be on the premises after 21:00 except where they are part of a pre-booked event and supervised by a person aged no less than 18 years old.

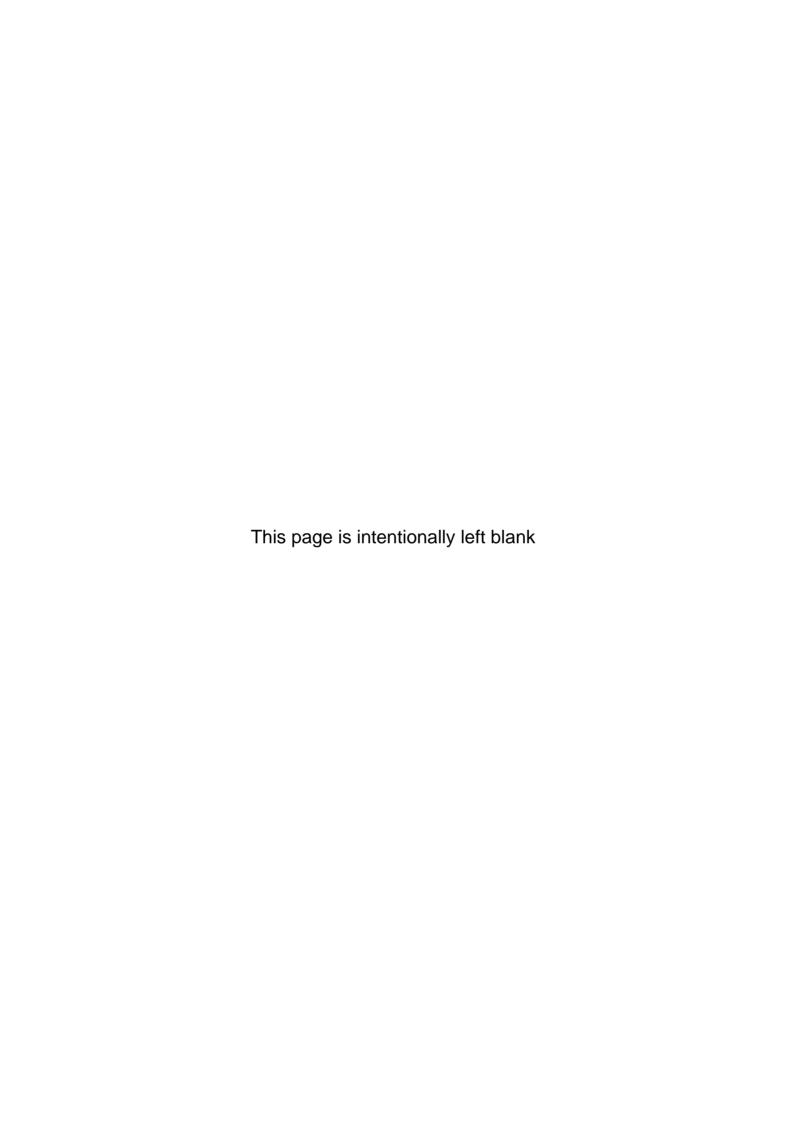
They are located in a residential area of the town, a 1am or 2am license would cause great upset to the local residents due to noise pollution,
