# NORTHAMPTONSHIRE COUNTY CRICKET CLUB

The licensing authority, West Northamptonshire Council, received a report on the application for a variation of a premises alcohol license at Northamptonshire County Cricket Club, Abington Avenue, Northampton.

The application was considered by the Licensing Committee at their meeting on 06 September 2021 held by Video Link. The hearing was conducted as per the Committees standard procedures.

# The committee heard from:

# Martin O'Connell – West Northamptonshire Council Licensing Officer

Mr O'Connell read the report to the Committee.

### Jonathan Taylor – Operations Manager, Northamptonshire County Cricket Club

Mr Taylor made representations including providing the operation of Northamptonshire County Cricket Club and the business in support of the application. Application made in support of a proposed concert and will allow the Club to offer further events. Confirmed Club is comfortable with proposed additional conditions.

## PC Sandy Tracey – Northamptonshire Police

PC Tracey confirmed no further representations from the police as proposed additional conditions have been agreed.

## The Committee received legal advice as follows:

- The options available to the committee are laid out in the report and the Committee must consider which option, in their consideration, is reasonable based upon this hearing.
- The decision must be made solely by the committee members and only by those members who have heard the whole application.
- The Committee must take such steps as it considers appropriate for the promotion of the licensing objectives;

- The Prevention of crime and disorder
- Public Safety
- o the prevention of public nuisance
- the protection of children from harm

To ensure natural justice, the Committee should give reasons for their decision.
